**Minutes**

**CALL TO ORDER**

President Richard Rodriguez called the meeting to order at 12:03 p.m.

**ATTENDANCE**

Members of the Board present included Richard Rodriguez, Phil Balmat, John Herrick, Bill Koster, and Molly Watkins. Kamal Bagri (SJC Ag Commissioner's Office), Parry Klassen (Valley Water Collaborative), Krista McCoon (RCD), Sonya Miller (NRCS-Stockton), Ruth Mulrooney (SJCDWQC), and Kelle Schroeder (SJC Ag Commissioner's Office) were also in attendance.

**MEETING AGENDA**

A motion to accept the agenda for the March 20, 2025, meeting was made by Ms. Watkins. Mr. Olagaray seconded the motion. Motion passed unanimously.

**MEETING MINUTES**

A motion to accept the regular meeting minutes from February 20, 2025, was made by Ms. Watkins. Mr. Olagaray seconded the motion. Motion passed unanimously.

**GUEST SPEAKER –**

Mr. Parry Klassen from Valley Water Collaborative discussed the work the group is doing in the subbasin. He noted the VWC represents 5 subbasins. He discussed progress in this subbasin as well as others. He noted in other areas it's costing \$80-100/house to provide water to those who qualify. Recruiting has begun for participants. A large report is due in year 3, which will be costly.

**TREASURER'S REPORT**

All bills for the month were presented. A motion to pay all invoices presented in the packets was made by Mr. Koster. Mr. Hamm seconded the motion. Motion passed unanimously.

**NRCS UPDATE**

EQIP and Personnel Update – Ms. Miller said EQIP applications are open, selections will be made soon. IRA funding is on hold. If it's not available, those applications will be put aside. She explained there is currently a hiring freeze while three previously released employees are on a 45-day admin stay.

**RESOURCES**

- A. Ag Commissioner's Report – Ms. Bagri introduced Kelle Schroeder, the new Assistant Agricultural Commissioner. She discussed that pest prevention funding is stable within the Farm Bill. She noted that cross training detector dogs is something being reviewed, and new training

sites are being evaluated. Ms. Bagri noted she attended Ag Day at the Capitol. She let the group know that pest detection program for fruit flies was cut by 3%. There is potential to partner with the RCD as weed management funds are available to address invasive weeds. The group discussed doing something to address Tree of Heaven. Spray Day notices must be submitted electronically. Regional DPR offices are being established.

- B. CARCD (California Assoc. of Resource Conservation Districts) Report – Ms. Watkins discussed the CARCD board changed the name of the JEDI committee without consent of the board. There is growing concern regarding the processes and procedures, or lack thereof. The board discussed various committee positions available. The following board members agreed to apply to these committees: Water – Bill Koster and John Herrick; Land and Soils - Phil Balmat, Ryan Hansen, and Richard Rodriguez.
- C. RCD Administrator Update – Ms. McCoon provided updates as agenda items came up.

## **IRRIGATED LANDS REGULATORY PROGRAM**

- A. Financial Report – All bills for the month were presented. Mr. Koster moved to pay coalition invoices as presented and accept and file the financial report. Mr. Olagaray seconded the motion. Motion passed unanimously.
